It is a public-private collaboration that strives to minimize the trauma of child abuse through a team approach to the investigation, prosecution, and treatment of serious child abuse cases. The team approach consolidates law enforcement, Child Protective Services, prosecutors, therapists and volunteers in one location.

**Clinic Program:** crisis counseling; individual and group therapy; court preparation; consultation with team; extended therapeutic assessments; and psychological testing as needed.

**Services Program:** information and referral; victim's compensation assistance; videotaped forensic interviews; coordination of medical services; and follow-up services.

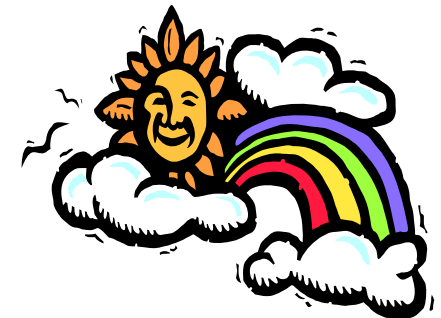
